## LAWFUL BASES AND DATA PROTECTION RIGHTS

**Your right of access** - You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. ## HOW LONG WE KEEP INFORMATION
